according to ^{the} Rules of the Office issued to make ^{the} same Publick ^{the} being returned
^{the} Indor. in Under ^{the} Hand of Tho: Sorrell Dep^t Clerk of ^{the} County Certifying that
the same was duly published & no Person appearing to dispute ^{the} Title to ^{the} Escheat
And ^{the} S^r. Sam^t. Duchiminia moving to be preferred to Escheat ^{the} same R^{to} 1710
Yeltherefore have for & in consideracion of ^{the} Composition to us paid & ^{the} annual
Rent hereafter Reserved have Granted Made Over & Confirmed And by these
Present Do Grant Make Over & Confirm unto ^{the} S^r. Sam^t. Duchiminia all our Right
Title Interest claim & Demand of in & to ^{the} four hundred & forty Acres of Land
to us belonging or Appertaining by virtue of ^{the} Escheat ^{the} Land Situate
lying & being in Upper Machotique in ^{the} County of Westmorel^t. Bore^t. And bounded
according to ^{the} Survey as followeth Vizt.: Beginning at a Hickory Corner tree
to this Land & ^{the} land ^{of} S^r. Sam^t. Duchiminia now lies on standing in ^{the} line of Tho: Butler
by a Road extending to a Hickory Saplin standing in ^{the} line of another parcel of Land of
^{the} S^r. Duchiminia along ^{the} line of Tho: Butler South fifty two degrees West One hundred
